### 1. Respective responsibilities of the body and the auditor

### 2. 2016/17 External auditor report (HU0150)

Except for the matters reported below, on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no other matters have come to our attention giving cause for concern that relevant legislative and regulatory requirements have not been met.

The Annual Return was not accurately completed before submission for review:

- We note that although Box 4 for the current year correctly comprises only payments made in relation to the employment of staff, including only employment expenses which are benefits (mileage, travel, etc.), but not items of reimbursement of expenses (e.g. for postage, stationery or other outlays made on behalf of the smaller authority); the prior year figure for Box 4 includes both types of expenses in error.
